Children and young people services committees (CYPSC) are set up in every county across Ireland as part of the Government's plan to get the best outcomes for children and young people from birth to 24 years of age. The purpose of the CYPSCs is to bring statutory, community and voluntary agencies providing services to children and young people together, to cooperate and plan and work in the coordinated way.

Donegal CYPSC has a countrywide structure, which supports this joint planning and coordination across all of Donegal. This will ensure that our children, young people, and their families receive improved add accessible services. This in turn will help Donegal children and young people to achieve they **National Outcomes** set out in better outcomes brighter futures the national policy framework for children and young people 2014-2020:

What is a Children and Young People's Services Committee?

Children and Young People's Services Committees (CYPSC) are a structure for bringing together a diverse group of agencies in local county areas to engage in joint planning and co-ordination of services for children and young people.

The overall purpose of CYPSC is to secure better outcomes for children and young people.

Children and Young People's Services Committees (CYPSC) are a key structure identified by Government to plan and co-ordinate services for children and young people in every county in Ireland. Children and Young People's Services Committees promote, support, and deliver national and local interagency working across services that work with and for children and young people in Ireland.

Children and Young People's Services Committees secure better outcomes for children and young people by:

- *Coordinating the implementation of national and regional policies and strategies that relate to children, young people, and families.*
- *Planning and coordinating services for children and young people in the area covered by the CYPSC.*
- *Eliminating fragmentation and duplication of services by ensuring more effective collaboration between children, young people, and family services within the area*
- *Influencing the allocation of resources*
- *Strengthening the decision-making capacity at local level*

The Department of Children, Equality, Disability, Integration, Youth (DCEDIY) provides funding, and strategic and policy direction for CYPSC. Four original sites were chosen to pilot this interagency work in 2007 (Dublin City, South Dublin, Donegal, and Limerick City). Since then, a national roll-out has seen CYPSCs established in all counties.

CYPSC have led and supported inspiring and positive programmes and activities in the fields of Literacy Development, Parenting Support, Early Childhood Development, Transitions to school, Youth Mental Health and much more.

Role of CYPSC Members

Representatives from a wide range of organisations within the statutory, community and voluntary sectors

contribute to local CYPSCs. Principally, the role of a CYPSC representative is to:

- Represent their department / organisation / programme / sector.
- Input to the education agenda of the CYPSC
- Share professional observations, knowledge, and experience.
- Advocate on behalf of their service users
- Advise on how the CYPSC can engage with children, young people, and families.
- Understand and appreciate ways that the CYPSC and its structures work.

A Children and Young People's Plan for Donegal

Each CYPSC is required to develop and then deliver on a three-year Children and Young People's Plan for the county. Each plan:

- Details how children and young people in the county are doing (**a socio demographic profile**)
- Describes what services, supports and groups are currently available in the county for children and young people (**an audit of services**)
- Identifies gaps and provides direction as to what the county can do better to improve services and improve outcomes for children and young people (**a needs analysis**)
- Sets out what the CYPSC will do over a three-year period to improve outcomes under the five national outcomes for children and young people (**an action plan**).

With a comprehensive picture of the needs of children, young people, and families in the county, CYPSCs then identify appropriate evidence informed and /or evidence-based responses. CYPSC projects and initiatives have contributed to improving outcomes for children and young people under a range of themes including Literacy, Parenting Support, Consultation with children and young people and Identification and assessment of the needs of children and young people.

Consultation with children and young people has been an integral part of the development of Children and Young People Plans.

National Co-ordinator for Children and Young People's Services Committees

Five National Outcomes for Children and Young People

The Government launched *Better Outcomes, Brighter Futures: The National Policy Framework for Children and Young People 2014-2020* on 16th April 2014. It is the first overarching national policy framework for children and young people aged 0 - 24 years. It recognises that almost all policy has a direct or indirect effect on children and young people's lives, underscores the necessity of interagency working and tasks Children and Young People's Services Committees (CYPSC) with a key role in this regard.

The work of Children and Young People's Services Committees is informed by the 5 national outcomes for children and young people as set out in *Better Outcomes, Brighter Futures*. The five national outcomes we want for all children and young people are that they are:

1. **Active and Healthy with physical and mental wellbeing.**
2. **Achieving full potential in all areas of learning and development**
3. **Safe and protected from harm.**
4. **Have economic security and opportunity.**
5. **Connected, respected and contributing to their world.**

Children and Young People's Services Committees National Steering Group

The Children and Young People's Services Committees National Steering Group (CYPSC SG) was established in 2012 to support the effective operation and practical implementation of Children and Young People's Services Committees at local level. It has reconfigured to align with the implementation structures in *Better Outcomes, Brighter Futures*. It has an independent chairperson.

The CYPSC SG chairperson is a member of the Children and Young People's Policy Consortium, representing and reporting on behalf of CYPSC.

Interagency Working

The need for interagency work is well recognised. International literature tells us that where evidence of the impact of interagency working does exist, it is mostly positive; although it takes time to become embedded in practice. When implemented well, interagency working achieves changes in the way we and our organisations work. Effective interagency working acts to create the 'permitting circumstances' for better functioning of front-line services and front-line staff. It is a vitally important part of improving outcomes for children, young people, and their families, by means of its potential to improve all the front-line services that support them.

The 3 key interagency messages of the CYPSC Initiative are:

Appendix 1 – Donegal CYPSC Terms of Reference

Terms of Reference for Donegal Children and Young People’s Services Committee

1. Purpose

The purpose of Donegal Children and Young People’s Services Committee (CYPSC) will be to provide strategic direction and leadership to ensure effective interagency co-ordination and collaboration to achieve the best outcomes for all children and young people in Donegal.

2. Donegal CYPSC Vision and Principals

The vision of Donegal CYPSC is that outcomes for Children and Young People are improved through inter-agency working.

The principles that underpin the work of Donegal Children and Young People’s Services Committee are:

- That Donegal CYPSC puts the best available evidence at the heart of planning and reporting processes.
- That Donegal CYPSC planning is outcomes based, i.e., its purpose is to achieve agreed outcomes.
- That Donegal CYPSC members own and direct the work of the committee and hold themselves and others accountable to the common agenda as expressed in this plan.
- Donegal CYPSC is committed to collecting and using data to make informed decisions. Alongside quantitative data, the committee recognizes the value of qualitative research to understand the experiences, meaning and views of children and young people and service providers.
- Donegal CYPSC stakeholders are open to learning through reflection on how well the work has lived up to performance expectation.
- Regular and open communications will flow - bottom up, top down and across the CYPSC initiative.
- The work of Donegal CYPSC will be children-centered and children and young people will participate in a structured and supported way.
- Donegal CYPSC has a commitment to equality and human rights, and this will be reflected in its work.

3. Term

These Terms of Reference will be effective for the period of implementation of the Donegal Children and Young People’s Plan 2021 – 2023.

4. Membership

Donegal CYPSC will comprise representatives from the principal statutory, community and voluntary organisations providing services to children and young people in Donegal.

Organisations may be invited to join the committee at the discretion of the Chairperson or by decision of the committee.

5. Roles and Responsibilities

Chair of the CYPSC

The Donegal CYPSC will be chaired by the Tusla Area Manager.

The key responsibilities of the Chair include:

- To provide leadership and direction for the Committee
- To ensure the effectiveness of the Committee in all aspects of its role
- To take a lead role in determining and reviewing the process regarding the composition, structure, and performance of the Committee

Vice Chairs of the CYPSC

The Local Authority representative from Donegal County Council will act as Vice Chair of the CYPSC. The Vice Chairs will support the Chairperson in carrying out his/her responsibilities. The Vice Chairs will deputise for the Chairperson when required.

The CYPSC Co-ordinator

The key responsibilities of the Co-ordinator include:

- To communicate a clear sense of purpose and direction on behalf of the Committee
- To foster and develop relationships with key personnel, including committee members and other stakeholders.
- To ensure the collection, provision and reporting of relevant data and information
- To organise and administer meetings of the CYPSC and its subgroups.

CYPSC Members

The responsibilities of CYPSC members include:

- Understanding the role of CYPSC and how its structures work
- Inputting to the agenda of the CYPSC
- Representing their department / organisation / programme / sector
- Sharing professional observations, knowledge, and experience
- Advocating on behalf of their service users
- Feeding back to their department / organisation / programme / sector on the work of CYPSC
- Ensuring their department / organisation / programme / sector is contributing to the delivery of relevant CYPSC projects through contributions to CYPSC Sub-Groups and Task Groups
- Advising on how the CYPSC can engage with children, young people, and families.

6. Meetings

- All meetings will be chaired by the Tusla Area Manager for Donegal.
- A meeting quorum will be 6 members of the CYPSC.
- Decisions will be made by consensus. Where consensus is not possible, the CYPSC Chairperson will make the final decision.
- Where a member is unable to attend, they may nominate a representative who has decision-making responsibilities.
- Meeting agendas and minutes will be provided by the CYPSC Coordinator.
- Meetings will be held 5 times per year and will last 2 hours.

- If required, task group meetings will be arranged outside of these times at a time convenient to members.

7. Amendment, Modification or Variation

The Terms of Reference may be amended, modified, or varied in writing after consultation and agreement at a CYPSC meeting.
